| 1. Take Poverty Level * 1.5=1st chargeable rate | 1. $12760 * 1.5 = 19140$ |
| 2. Poverty level increment amount for each additional family member/2=increments to use | 2. $4480/2=2240$ |
| 3. 1st chargeable rate+increments to use=Annual Gross Income | 3. $19140+2240 = 21380$ |
